

The Bourbon County High School PTSA will hold the election of the parent member for the BCHS SBDM School Council member on May 19, 2016 at the Bourbon County High School from 8:00 am – 3:00 pm and then again from 5:00 pm – 6:00 pm.

Nomination Forms must be completed and returned to BCHS in an envelope marked PTSA SBDM. A Nomination Form is attached to this notice.

INFORMATION ON SBDM SCHOOL COUNCILS

What is the school council? The council is the governing body for this school. It determines school policy for curriculum, staffing, discipline, scheduling, instructional practices, extra-curricular activities and other matters pertinent to the operation of the school. The council meets on the 2nd Thursday of every month at 4:30 p.m. in the library.

Who serves on the council? 2 parents, 3 teachers, and the principal.

Who may run from council? Any parent, step-parent, foster parent or legal guardian of a student who will be attending the school during the parent's term of office. A parent is ineligible if he/she is an employee or a relative of an employee of that school or the district central office, or a local school board member or the spouse of a school board member.

How will I know who is running for council? The slate of nominees will be listed on the BCHS SBDM webpage and will be sent out on the one call system.

If I want to run for the council, what do I do? Complete the attached nomination form and return it by 3:00 p.m. on May 16, 2016. You may nominate yourself or another parent, if you have the parent's consent. Nominations from the floor will not be permitted.

Who may vote in the election? Parents, step-parents, foster parents, and legal guardians of students attending BCHS during the 2016-2017 school year.

When do we vote? Voting will take place May 19, 2016 at the Bourbon County High School from 8:00 a.m. – 3:00 p.m. then 5:00 p.m. – 6:00 p.m. One parent member will be elected to serve on the council. There will not be absentee ballots allowed.
